### Interview with Engr. Taiwo Elegba FNSE, on Capacity Building

Engr. Taiwo Elegba FNSE is the General Manager, Capacity Building, Nigerian Content Development and Monitoring Board (NCDMB). He is the Immediate Past Chairman of NSE Victoria Island Branch.

#### E-Newsletter: Sir, please can you us more on Capacity building as regards to your assignment?

Engr. Taiwo: I'm in charge of capacity building and we are building capacity in all ramification; Human, Infrastructure and Manufacturing and also Institutional. Presently we are trying to capture electricity capacity in Nigeria. It involves human and manufacturing. We move around. For example we are aware that there are some docks along the Niger coast that are lying down there and we still have people taking their ship out servicing. We want to bring all other staff, they need to advertise. Then these docks to a serviceable state. We also look at industries, all these small fabrications and manufacturing companies, what they need and what they are over the system and we will then direct lacking. We sit down with them and discuss and fashion out ways to improve their capacity. Now in human develop- it". ment, we also train some lectures and people working in the industry; fitters, welders, divers; such people. We are



Then at the end of the day, we are putting the J Key system into place, which is information system, that is a huge data bank system we keep very close to us while we capture the human capacity in manufacturing, industry, etc and bring it in here so that if a company may need an engineer or any we need to check the system, "do we have this kind of material, no we don't have it". If we have it, we will see it the people to that place, "this gentleman is capable in doing this thing. Go and do



That will even help. If we don't have in that system what is required then approval can now be given to that company to out source such qualified personnel. We would then put in place as soon as we can to develop that capacity in Nigeria. We must have a plan on that basis.

The board is the one monitoring the performance of the people in the oil industries, and the servicing companies. We ensure that they are actually abiding by the law. How do we do this? When they have any project to do, we ask for the plan. We want to see their Nigeria Local Content Plan and where they really have genuine cases we can sit down and look at how we can overcome that problem. That is what we are doing now.

E-Newsletter: Thank you very much Sir. Our last question is what measure do you have in place because it is a two way thing. You and the stakeholders. What word do you have for our readers so that stakeholders can actually help you to help them as to help the system?

**Engr. Taiwo:** When you say stakeholders, I believe all of us are stakeholders; the companies, Boards, the general public and engineers specifically. We are all stakeholders. The thing is that everybody must be on ground. There was an advert that the Board sent out that people should submit their capacity, what they can do, their qualifications, what they have been doing, they should submit to us, so that we can put in our data base. So that we can know that somebody somewhere in Port Harcourt, in Bonny when we are looking for such a person we will get him. Then also are so many small and medium size industries in Nigeria that are in the oil industry and we don't even know their capacity and companies are saying that they can't do this, they can't do that. It is because of all these things we made that advert in the paper .
